

#### AGREEMENT FOR THE LISTING OF SERVICES ON THE NTP TOURISM PORTAL

**This Agreement** (the "Agreement") is made and entered into as of the date below by and between:

National Tourism Pakistan having its principal office at Sir Syed Avenue, H-13, Islamabad. (hereinafter referred to as the "Service Provider" or "NTP")

	AND
, having its principal office at	
, naving its principal office at	
, (hereinafter referred to as the "Partner")	

WHEREAS, the NTP operates and maintains an online tourism platform known as the NTP Tourism Portal "www.nationaltourism.pk" ("Portal"), which provides listings and services related to tourism, including hotels, restaurants, tour operators, travel agents, boat operator, transporter, and tourist guide;

**WHEREAS**, the Partner wishes to list its services on the Portal to enhance its visibility and reach customers seeking tourism-related services;

**NOW, THEREFORE**, in consideration of the mutual covenants and promises contained herein, the parties agree as follows:

#### 1. Scope of Services

- **1.1** The Partner agrees to list their services, which may include hotels, restaurants, tour operations, travel agency services, boat operations, transporter and tourist guide service on the nationaltourism.pk.
- **1.2** The listing shall include all relevant details such as service offerings, pricing, availability, and any other necessary information.
- **1.3** The Partner agrees to maintain the accuracy and completeness of the listing throughout the term of this Agreement.

#### 2. Duration of Agreement

- **2.1** This Agreement shall remain valid unless terminated earlier in accordance with the provisions of this Agreement.
- **2.2** Either party may terminate this Agreement by providing 30 days written notice to the other party.
- **2.3** NTP reserves the right to terminate this Agreement immediately in the event that the Partner fails to provide proper services to clients or breaches any of the terms of this Agreement.

#### 3. Service Charges

- **3.1** The Partner agrees to pay a 10% service charge on every booking made through the Portal, calculated on the total value of the booking.
- **3.2** NTP will deduct its service charge of 10% from each booking, and the remaining amount will be transferred to the Partner's account. The deductions and transfers will be processed on a fortnightly or monthly basis.
- **3.3** NTP reserves the right to update or modify the service charge percentage with prior written notice to the Partner.

# 4. Payment Terms

- **4.1** Payments for bookings made via Portal shall be processed through the NTP's payment system.
- **4.2** The NTP shall ensure that all payments due to the Partner under this Agreement are paid according to the agreed payment terms, either fortnightly or monthly.

# 5. Obligations of the Partner

- **5.1** The Partner shall provide the NTP with accurate, up-to-date information about its services, including availability, pricing, and contact details.
- **5.2** The Partner shall respond promptly to customer inquiries received via the Portal.
- **5.3** The Partner shall be responsible for delivering the services booked through the Portal according to the terms and conditions advertised on the Portal.
- **5.4** The Partner agrees to maintain proper licenses, permits, and insurance required to operate their business legally.

# 6. Obligations of the NTP

- **6.1** NTP shall list the Partner's services on the Portal and make them available for booking by users of the Portal.
- **6.2** NTP will provide customer support for bookings made through the Portal, including managing payment processing and providing the Partner with relevant booking details.
- **6.3** NTP will maintain the confidentiality of all sensitive information provided by the Partner.

# 7. Confidentiality

**7.1** Both parties agree to keep all proprietary or confidential information received from the other party in the course of this Agreement confidential and not to disclose it to any third party without the prior written consent of the other party.

#### 8. Termination

- **8.1** This Agreement may be terminated by either party if the other party fails to comply with the terms and conditions set forth herein, and such failure is not remedied within 30 days of written notice.
- **8.2** Upon termination, the Partner's listing will be removed from the Portal, and any outstanding payments due to the NTP will become immediately payable.

#### 9. Indemnity

**9.1** The Partner agrees to indemnify and hold the NTP harmless from any claims, damages, or losses arising from the Partner's failure to deliver the services or fulfill any of its obligations under this Agreement.

# 10. Limitation of Liability

**10.1** NTP shall not be liable for any direct or indirect damages arising from the Partner's use of the Portal or from any bookings made through the Portal.

# 11. Dispute Resolution

**11.1** In the event of any dispute or claim arising from this Agreement, the parties shall attempt to resolve the matter through negotiation. If resolution is not reached, the dispute shall be referred to binding arbitration.

#### 12. Miscellaneous

- **12.1** This Agreement shall be governed by and construed in accordance with the laws of Islamabad.
- **12.2** Any amendments to this Agreement must be made in writing and signed by both parties.
